I. Call to Order

Commissioner Kohn called the meeting to order at 7:10 PM.

II. Roll Call

III. Approval of Minutes

Commissioner Kramer moved to approve the minutes of the March 13, 2017 Human Relations Commission meeting. Commissioner Holmes seconded. The motion was unanimously approved.

IV. Old Business

a. Human Relations Commission Award

Commissioners noted that Village Staff could not nominate a person, and if a Village of Lincolnwood employee was nominated, they would not be able to accept a gift; a plaque would be acceptable. As of this date, no applications have been received.

b. Niles Township Food Drive

Commissioners were asked to check their assigned food boxes. The boxes will be collected by Community Service Officer Mark Weidner after April 15, 2017.

c. Village of Skokie Welcoming City Ordinance

Commissioners reviewed and briefly discussed the Village of Skokie Welcoming City Ordinance. Commissioner Kohn invited the public to speak.

1. An individual who identified herself as a representative of the Multi-Cultural Task Force stated she strongly supports the Village of Lincolnwood adopting a similar ordinance.

2. Another person identified herself as a representative of the Indivisible Lincolnwood organization. She supports the Village of Lincolnwood becoming either a Welcoming, or Sanctuary city.
3. A woman who identified herself as a Lincolnwood resident appreciates the diversity of this community and would like the Village of Lincolnwood to mirror the Village of Skokie Ordinance.
4. One last person who identified herself as a resident spoke, stating that when she drives through Skokie and sees the welcoming signs on lawns, she feels touched and asked that Lincolnwood provide the same signs to make people feel welcome.

After discussion, Commissioner Foutris motioned to table the issue, and Commissioner Orah seconded. The motion was unanimously approved.

- d. Village of Streamwood Community Relations Commission Art Around the World Event, April 22, 2017

Commissioner Kohn will contact the organizer to gather ideas for a future Lincolnwood event.

- e. 2017 Cultural Diversity Events
