Prior to certification, candidates are required to pass a medical examination, psychological evaluation, polygraph examination, and background investigation. Candidates must also pass the entrance requirements for the State mandated Basic Recruit Training Course.

The Eligibility List will be in effect from June 4, 2015 and expire on June 3, 2016. The Board may approve up to two, six-month extensions of the Eligibility List. Under no circumstances will the List be valid for more than twenty-four (24) months in aggregate.

In an effort to ensure that there are a sufficient number of eligible applicants, the Board may elect to interview a second band of applicants at any time. As a result, a new Eligibility List will be created which will supersede any existing Eligibility List.
