President's Message



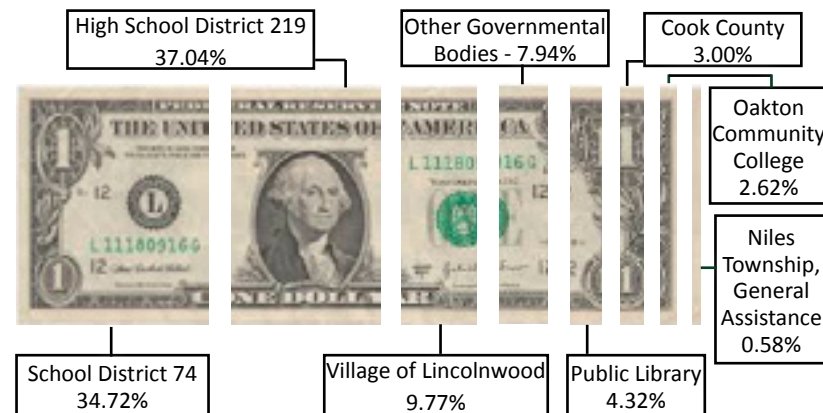
Dear Fellow Residents,

The end of winter has to be near! With the equinox in sight in a few weeks, we will officially be in spring's grasp. There are some important things to mention about recent progress in our Village.

By now you have received the first installment of your 2015 property tax bill from the Cook County Treasurer which includes information about the various taxing bodies. You should know that of all the taxing bodies in our Village, the municipal taxes make up only about 9.77% of the total tax any of us will pay. Our figure still remains the lowest in Niles Township and the lowest among our neighbors in all directions surrounding us.

Understanding Your Tax Bill

On your property tax bill, you will find a break down of the taxing bodies that receive funding from property taxes. The Village receives a minor portion of the overall property taxes along with the school districts, other governmental bodies, public library, community college, and the township. The graphic on the right shows the percentages that each of the taxing bodies receives from all property taxes collected.



Binny's Beverage Depot will open its 31st store in Lincolnwood in the former Lincolnwood Produce site at Lincoln and Kostner this year. In addition to Binny's, Begyle Brewery, a Chicago based craft beer manufacturer, has begun renovation of the former Collision Revision property adjacent to the Lincolnwood Town Center Mall. North Capital Group, developer of the former Purple Hotel site, is currently securing a construction loan and are planning to begin construction on the site in the fall of 2016.

On March 24th I will be speaking to members of the business community in our annual "State of the Village" speech to highlight our significant achievements in 2015. The material below covers some of the accomplishments of the Village President and Board with future editions to cover the accomplishments of our departments.

- Approved final design plans for the Touhy Avenue Pedestrian/Bicycle Overpass
- The Cook County project for infrastructure and road surface improvements on Crawford Avenue was completed in August.
- Worked in cooperation with IDOT to address the center median project on Lincoln Avenue to remove the asphalt as new lighting was installed. The next phase of planting natural vegetation on the medians will begin in the near future.

Village departments continued to partner with the business community in 2015 to create special events. The most notable was our Lincolnwood Turkey Trot which had the largest registration ever at 2,200 participants. Sponsoring businesses included Republic Bank, Chroma Salon Spa, Lou Malnati's, Accelerated Rehabilitation Center, Advanced Plastic Corporation, Olympia Group, Voss Belting, Starbucks, Meatheads, MB Financial Bank, and Children's Care & Development Center. The Human Relations Commission and Village Departments continued to partner with local businesses. These partnerships included MB Financial, Brickyard Bank, Republic Bank, Bank Financial, and Liberty Bank for our annual Food Drive and Independence Day Concert. The Parks and Recreation Department also hosted Pumpkins in the Park sponsored by NorthShore University HealthSystem, Liberty Bank, Dental Art Specialists of Evanston, and Jump Zone of Niles. The event attracted over 300 residents who enjoyed Halloween-themed activities and entertainment at the Proesel Park Shelter. You will hear much more at the luncheon. I will hope to see you there.

New Parks and Recreation Director Hired

On November 30, 2015, Janice Hincapie retired from the Village of Lincolnwood as the Parks and Recreation Director after nine years with the Village and over 30 years of public service to Wisconsin and Illinois communities. After a comprehensive recruitment process, the Village has appointed Laura McCarty to the position of Parks and Recreation Director. Ms. McCarty's first day with the Village was Monday, January 18, 2016.

Laura grew up in Park Ridge and brings a wealth of experience having served in the Wheaton Park District before moving to Virginia to serve as the South Run Recreation Center Manager for the Fairfax County Park Authority in Virginia. Laura most recently served as the Park Operations Superintendent for the Northern Virginia Regional Park Authority (NOVA) where she was directly responsible for managing 17 multifunctional regional parks that covered over 5,400 acres of land. Comprehensive Plan Meeting

On Wednesday, April 13 at 7:00 p.m., a public hearing will be held before the Plan Commission regarding the proposed new Comprehensive Plan. After nearly a year, the Comprehensive Plan Committee has completed its work on a new Comprehensive Plan. All interested residents are invited to attend the meeting and provide comments on the proposed plan. The Village's consultant, Houseal Lavigne Associates will deliver a presentation on the proposed plan at the public hearing to be held in Council Chambers at Village Hall, 6900 N. Lincoln Avenue.

The Comprehensive Plan is an important document which guides future land use decision-making. Typically a community prepares a new plan every 15 to 20 years. The previous Comprehensive Plan was adopted in 2001.

ComEd Warns Customers of Increase in Scams

ComEd wants residents to be aware that scammers are contacting their customers by phone and in-person claiming to be ComEd representatives and telling them their service will be disconnected unless payment is made. Representatives from ComEd always carry proper identification and never ask customers for cash or personal financial information. Customers can avoid being scammed by taking a few precautions:

- Never provide your social security number or personal information to anyone initiating contact with you claiming to be a ComEd representative or requesting you to send money to another person or entity other than ComEd.
- Be skeptical of individuals wearing clothing with old or defaced company logos. If you have any doubts, ask to see a company photo ID.
- Never make payment for services to anyone coming to your door.

Lincolnwood Summer Day Camp

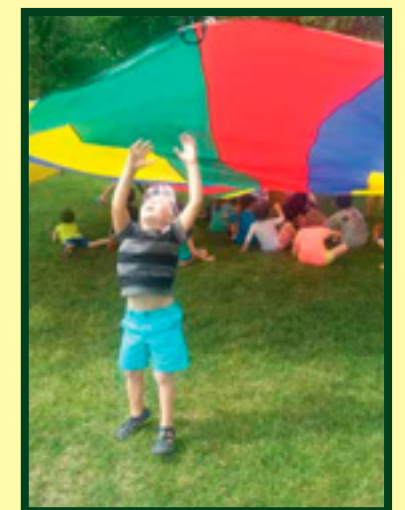

Proesel Park Shelter Reservations

Public Works



Groot Garbage Pickup

The Village's waste hauler, Groot, picks up garbage and recycling every Monday. During 2016, Groot will observe the following holidays that fall on Sundays or Mondays: Memorial Day (May 30), Independence Day (July 4), Labor Day (September 5), and Christmas (December 25).

On each of these weeks, refuse and recycling will be collected on the following Tuesday. If a pickup is missed during regular pick up, residents must call Public Works on Tuesday prior to 11:00 a.m.

It is illegal to deposit electronic products into your garbage. Groot offers collection of electronic items such as computer equipment, televisions, and DVD players for a fee. To make arrangements for a pick up of electronic products, please call Groot at (847) 734-6400.

Yard waste pick up will resume on March 14. Groot will not pick up garbage that is mixed with branches and yard waste. If you have yard waste in your garbage, Groot will notify you by placing an orange tag on the garbage bin, and you must separate your garbage from the yard waste, then schedule a pick up by contacting Groot at (847) 734-6400. When disposing of yard waste, please ensure that branches that are four inches or less in diameter, four feet or less in length, and tied together in bundles of 60 pounds or less.

Yard waste bags are available for purchase at the Village Hall at a cost of \$2.00 for five bags. If you have questions, please contact the Public Works Department at (847) 675-0888.

Animal Control Program

The Village has an animal control cost sharing and reimbursement program for opossums, raccoons, and skunks. If you are encountering problems with any of these animals, contact the Public Works Department. The Village's contractor, Animal Control Specialists, will make an appointment with the property owner to set up a trap.



The property owner must pay Animal Control Specialists \$90 to set the trap and \$55 for each animal caught. Once the invoice is paid to the vendor, they will provide a copy to the Village and the Public Works Department will process a reimbursement of up to \$200. Animals inside the home or on the roof are not covered under this program. Please contact the Public Works Department at (847) 675-0888 if you have questions about the program.

Water Testing for Lead

Lead enters drinking water primarily through plumbing materials in your house such as faucets or fittings made of brass which may contain some lead, copper pipes with lead solder, and lead pipes including services lines. The Illinois Plumbing Code prohibits the installation of new lead pipes to provide water service to residential properties; however, homes built before 1991 may still have a lead service line. The Public Works Department estimates that approximately 75% of the residential properties in the Village receive water through lead service lines.

In accordance with the Environmental Protection Agency's (EPA) 1991 Lead and Copper Rule, the Village takes samples from 30 residential properties across the Village to test for elevated levels of lead. Testing is conducted every three years, with the most recent testing taking place on June 3, 2014. The results of those tests showed that the Village is well within the acceptable levels of lead per EPA guidelines. The results of the most recent lead testing are available in the 2014 Annual Drinking Water Quality Report, which has been posted to the Village's website at www.lincolnwoodil.org/resident-services/understanding-your-water-bill/.

Infants and young children are typically more vulnerable to lead in drinking water than the general population. It is possible that lead levels may be elevated in specific homes due to materials used in the private plumbing system as outlined above. Residents who are concerned about elevated levels of lead may wish to have their water tested; kits are available commercially. Residents may also try flushing the tap for 30 seconds to 2 minutes before using tap water. Additional information is available from the Safe Drinking Water Hotline at (800) 426-4791.

Tree Removal Permits

The Public Works Department would like to remind residents that a tree removal permit must be applied for to remove any private property tree that is eight inches or greater in diameter. 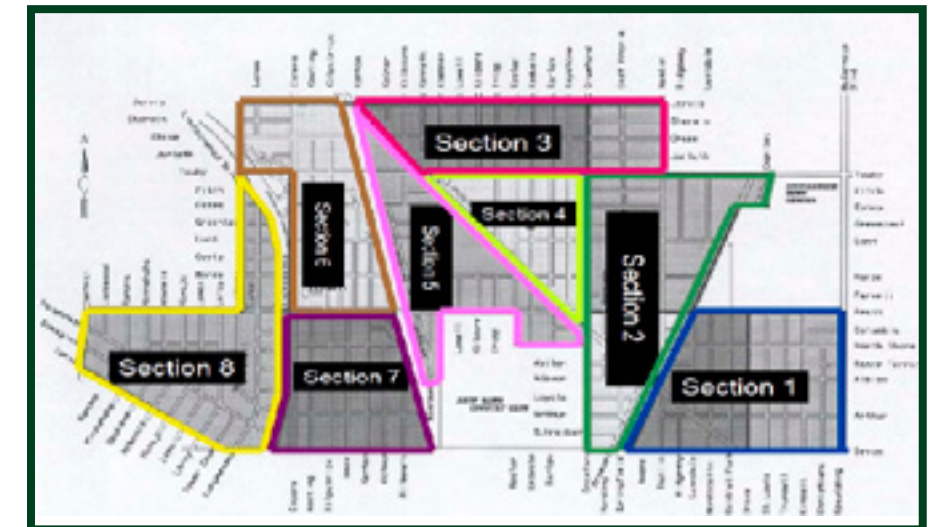


Permanent Street Sweeping Reminders

Each year, the Public Works Department performs street sweeping throughout the Village to keep streets clean as well as to prevent dirt and debris from entering the Village's sewer system. Signs are located on each block notifying residents when street sweeping will occur in the area. Street sweeping is a two day process. Motorists should not park on the side of the street where street sweeping will occur that day.

Residents will have street sweeping performed every month on the same day of the week. Street sweeping will resume on April 1. In the street sweeping schedule, the following days are swept each month:

Section 1: First Tuesday and Wednesday
Section 2: First Thursday and Friday
Section 3: Second Tuesday and Wednesday
Section 4: Second Thursday and Friday
Section 5: Third Tuesday and Wednesday
Section 6: Third Thursday and Friday
Section 7: Fourth Tuesday and Wednesday
Section 8: Fourth Thursday and Friday



Hydrant Flushing

During the spring, the Village will begin to flush fire hydrants. Signs will be posted in the areas that will be affected prior to the start of the flushing operation. Periodic flushing of fire hydrants is an important preventative maintenance activity to maintain the integrity of the water system and ensure quality water for all residents.

As a result of the flushing procedure, residents in the immediate vicinity of the work may experience temporary discoloration of their water. This discoloration consists of harmless silt and precipitates and does not affect the safety of the water. If you experience discoloration in your water after crews have been flushing in your neighborhood, clear the pipes in your home by running all water faucets. If you have additional questions regarding hydrant flushing, please contact the Public Works Department at (847) 675-0888.



RPZ Testing Compliance

As spring approaches, please remember that a licensed and certified back flow prevention assembly tester must perform an annual back flow prevention test and certification on all RPZ valves installed on irrigation or fire suppression systems. The test report must be mailed to the Village's authorized agent, Back Flow Solutions, Inc. (BSI) at P.O. Box 246, Worth, IL 60482 or faxed to (888) 414-4990.

If you have a lawn sprinkler system and do not have an RPZ valve installed, you must do so immediately. Plumbing cross-connections, defined as actual or potential connections between a potable and non-potable water supply, constitute a serious public health hazard. If you have questions regarding the Village's Cross Connection Program, please contact the Public Works Department at (847) 675-0888.

Sewer Line Rebate Program

If your home has experienced a backup in your private sanitary sewer line and a repair or replacement of the line is necessary, you may qualify for the Village's sewer line repair rebate program. For collapses determined to be in the Village right-of-way and that are directly caused by tree roots from a Village owned tree, the repairs and/or replacement may be eligible for a rebate up to \$2,000.
