

**RELEASE AND WAIVER**

I acknowledge that I am and will remain the owner of the Materials and further that I created the Photographs and am able to grant the rights to the Village which are being granted hereunder. Nothing herein obligates the Village to use my Photographs or any of the rights set forth herein.

I agree to indemnify and hold harmless the Village from and against all claims, losses, expenses and liabilities of every kind, including reasonable attorneys’ fees, arising out of the inaccuracy or breach of any provision of this Release and Waiver.

I expressly release the Village from any and all claims arising out of the use of my name, likeness, image, Photograph, including but not limited to, claims for blurring and distortion, invasion of privacy, defamation and infringement of the right of publicity

This Release and Waiver will in all respects be governed by and interpreted, construed and enforced in accordance with the laws of the State of Illinois, represents the entire understanding of the parties and may not be amended unless mutually agreed to by both parties in writing. I confirm that I am over 18 years of age and have the right, capacity, and authority to enter into this release and waiver. **IF THE INDIVIDUAL EXECUTING THIS RELEASE OR APPEARING IN A PHOTOGRAPH IS A MINOR (under 18 years of age), HIS/HER PARENT OR GUARDIAN MUST ALSO EXECUTE THIS RELEASE.**
