Consideration of a Recommendation by the Committee for Ordinances, Rules and Boards (CORB) that the Village Board Remand Plan Commission Case #PC-19-19 to the Plan Commission for Further Deliberation on the Issue of Creating the New Use "Dermal Pigmentation Establishment" to be Permitted in the M-B Manufacturing and Business District as a Special Use

This item was presented by Doug Hammel, Development Manager, using PowerPoint.

This came before the Board on October 2, 2019 and was referred to the Plan Commission

Plan Commission said that these were considered to be personal services.

Issued for a public hearing – there was a petition and 40 residents did not want a Tattoo Pallor to be in Lincolnwood.

The petition is still in process

CORB recommended that this business be located in the MB Manufacturing District to be addressed at the Village Board Meeting tonight.

There has been no denial – the Village Board has not approved any requests.

Please send back to more deliberations

Attorney Elrod stated, that this application is still in progress. CORB's recommendation is that this business should go not in B1, B2, B3, M-B was more appropriate.

Trustee Patel: CORB concluded that the M-B district would be a conducive location for the business.

Trustee Patel asked what CORB discussion entailed, Trustee Nickell clarified.

Trustee Nickell spoke regarding the meetings with two trustees and the Village Manager.

She stated that the Trustees have been advised to expect another round of meetings with staff, two trustees at a time to review a proposal from Washington Prime. She stated that she has expressed concern and reluctance regarding this two by two format. She stated that the last time this format was used was to discuss the water connection with Evanston. At that time she spoke to all in attendance and to the Village Manager regarding her concerns and reservations about the lack of transparency in conducting business in this manner.

She went on to state that we have exceptions which allow the Board to meet in Executive Session to discuss sensitive negotiation components. Any business looking to locate in Lincolnwood – or even an existing one seeking incentives- should follow the proper channels that exist through EDC or COTW. This is a recent practice.

She stated that this Board is often divided – and disagrees on various issues, however there is value in individual perspectives when shared by Board members and the public.

It is valuable to hear the opinions and ideas of others. She questions if this practice is good government.

She requested that her colleagues support termination of this practice and restore public meetings and workshops with full transparency.

Discussion ensued.

Village Manager Gaura stated that she feels that these meetings maintain a level playing field for all.

She would like to keep these meetings going because we have a large slate of Capital projects.

Trustee Sargon agreed with this approach.

Trustee Klatzco agreed that this approach offers better preparedness.

Trustee Halevi stated that as long as there is no voting at these 2 by 2 meetings, she agrees.

Trustee Nickel asked if the information discussed at these meetings will be made public.

Ms Gaura responded that if the developer has asked that certain information be kept private, it would not be made public.

Trustee Nickel stated that she would not participate in these meetings/

President Bass announced that consensus minus Trustee Nickel is to continue with 2 by 2 meetings with the Village Manager
